

LAKE MURRAY ASSOCIATION MINUTES
February 8, 2010

NEW BUSINESS:

Public Meeting: Dave Landis

The next public meeting will be at the Saluda Ruritan Club on February 23, 2010.

- House Check Program that has police checking on your lake property should you be away is going to be explained and represented by Saluda, Lexington and Richland County Sheriff’s offices.
- Saluda County Grant will be explained by Rebecca Spratlin of DHEC. The overview of this grant is to reduce the fecal coliform bacteria found in the Little Saluda and Clouds Creek Watershed. They want to develop management practices for agricultural activities and septic systems in rural residential areas as well as addressing wildlife’s part in the fecal coliform in the water. This grant will be shared with Saluda County Planning Department, Clemson Extension, USDA Natural Resources Conservation Service and Saluda County Soil & Water Resource District. This came about because the little Saluda and Clouds Creek have been listed as having impaired water bodies with fecal coliform...they want to address this problem.
- Bill Argentari will update all on the Environmental Draft and let us know the decisions on the Low inflow outcome.
- There is a lot of pertinent and important information to deliver to this area at this meeting. We need to work to get people to attend the meeting. Flyers are being distributed by Ken Fox; Lee will try to get on the radio station in the area, invitations to

Rep. Marion Fry, Ronnie Cromer and the county commissioners to solicit their attendance.

Draft Environment Assessment: Dave Landis

We are waiting for this to come, shortly. It will let us see how close FERC stuck to the settlement agreement.

H452~House Bill 452: Irby Shultz

This bill is regarding a Water Withdrawal Permit. This bill is to ensure the protection for downstream users and the protection of our surface water. Water is in demand in all states to be used for industry and states want to claim or protect water for their state. SC is one of the few without a water plan in place and this is critical to all of us. We need to strengthen our protection of the water rights in SC. *McMasters is presently fighting NC on this same issue...it is a precarious position and one that can affect future issues with GA. Lake Hartwell is involved in protecting their water from GA.

- Irby reported that this bill was introduced on 2/19/09 and sent to committee on 1/28/10. The Senate will vote on it when a compromise is reached between stakeholders, per Debbie Parker.
- S.1072 and H. 4426 were also noted as a “water related” issue that honors our own Stan Jones of Lighthouse Marina. June 12, 2010 will be Annual National Marina Day in South Carolina to honor SC’s Marinas for their contribution to the community. This is to alert citizens, policy makers and employees to be aware of the overall contributions of Marinas make to their well-being. We are being asked to join hands with other states across the US to celebrate this day.
- Irby also passed out an information sheet showing how a bill becomes a law in SC. Thanks to Irby for a most interesting and organized presentation on water issues pertinent to all of us.

Membership Letter: Dave Landis

In a bold effort to strengthen our membership, Sharon took on a project to send a welcoming membership letter to all new lake residences. She sent out 200 letters welcoming these new residents encouraging them to join LMA. Tom will track these memberships to see the percentage that joined as a result.

- It was noted that there were extra copies of this letter for anyone to take to pass out in their neighborhood to encourage membership.
- Thanks to Sharon for making the effort to reach out to new people and to any who followed her lead. (It takes a “village”.)

Sea Tow Letter: Dave Landis

We have a copy of the letter that describes our new relationship with Sea Tow and what we can offer our membership. \$25 discount on a Sea Tow Membership by verifying your LMA membership and this continues as they renew each year. Once we have 150 LMA members join Sea Tow, they will give back a \$25 donation per member to LMA. This will be promoted at the Boat Show as we share a booth with Sea Tow.

401 Certification: Dave Landis

This will be discussed at a meeting at Saluda Shoals on March 11 @ 6:00 pm. Mark your calendars to attend. DHEC has the last word on the re-license. If you would like to speak, you will need to sign up ahead of time.

COMMITTEE REPORTS

Environmental: Roy Parker

Roy provided information regarding an article that had been written stating that there were Mercury contaminated fish in Lake Murray. He interviewed Dr. James Glover regarding this article to validate or refute what was written. The information learned:

1. There is NO advisory against eating fish from Lake Murray.
2. The use of the words “mercury poisoning” incites danger and implies a medical emergency...(an irresponsible use of words according to Pat)
3. There is NO acute toxicity in Lake Murray from Mercury...this is expanded to none in the USA.
4. Mercury levels in fish increase when there is dry weather or a drawdown and is caused by accelerated mercury methylation fostered by bacteria in dry soils of the shore line draw-down area.
5. The guidelines for setting mercury triggers for issuing fish consumption advisories differ for many issuing agencies. For example, the following parts per million (ppm) levels are given for the following agencies for issuing advisories: DHEC 0.25 ppm, EPA 1.00 ppm, FDA 1 ppm, Florida 0.5 ppm and The World Health Organization, 1 ppm.
6. The average level of mercury found in fish taken from Lake Murray was 0.26 ppm and no advisor was issued.
7. The highest level of mercury found in a Lake Murray fish was in the biggest fish sampled and was 0.89 ppm. Large predator fish accumulate mercury as they eat smaller fish.

Conclusion: There is no problem with Mercury contaminated fish in Lake Murray and the problem is decreasing...and eat only little fish! Thanks to Roy for taking the time to investigate this issue as there are many fisherman who had concerns...Roy will see if Dr. Glover would be willing to speak at our Lexington meeting.

News Letter: Sharon Miles Articles are due February 27. Sharon has found a way to save us money on the printing of the newsletter by using a 20% off coupon and buying a non-profit stamp that will reduce the mailing to .11 cents from .34 saving us 23 cents each. The old covers will be recycled to newsletters that are used to hand out at meetings. No waste, saved money...excellent job, Sharon!

Nominating: Aleda Anderson/ Bill East
