MINUTES – OCTOBER 10, 2006**

September Minutes and October Treasurer's Report were approved.

V-P Ken Fox called the meeting to order.

**OLD BUSINESS**

**Water Quality Monitoring Program – Roy Parker**

The most recent sample analyses were distributed to the Board. An introductory explanation of this program will be added to our website and will include a sample site map. Data from recent samples shows high phosphorous content moves into the lake following periods of rainfall. Further meetings with SCE&G are scheduled to present our program and discuss possible areas of mutual interest and the feasibility of using their testing facilities to process our samples.

**Budget and Funding – Bill East**

Budgets for the 2007 calendar year are needed by November 1 from each committee chairperson.

**September Public Meeting – Ken Fox**

This was perhaps one of the best programs presented in recent years and it was appreciated by a larger than average turnout.
